

ORDINANCE No. 91

AN ORDINANCE MODIFYING RATES FOR WATER AND ESTABLISHING UTILITY RECORD KEEPING AND AUTOMATIC UTILITY BILL ADJUSTMENT PROCEDURES.

THE CITY OF BETHEL ORDAINS AS FOLLOWS:

SECTION 1.

For the providing of water within the City, the following modified charges shall be made:

Residential/Commercial water delivery services involving the following capacities, frequencies and rate charges:

SECTION 3.

The City's Public Works Department, Utility Services Division, shall establish and maintain an utility record keeping system to include the following:


- (1) Number of gallons of water provided each utility services customer per delivery;
- (2) Number of sanitation containers (honeybuckets) evacuated per utility services customer per scheduled frequency;
- (3) Number of garbage, rubbish or waste material containers emptied per utility services customer per scheduled frequency;
- (4) Number of gallons of sewage evacuated from sewage holding tanks per utility services customer per scheduled frequency; and
- (5) Number of gallons of water and/or sewage piped per month per utility services customer.

Such utility records shall be maintained on file at the City's Public Works Department, Utility Services Division, for a period of one calendar year. Utility services customers may inspect such records during normal business hours of the City.


SECTION 4.

Customers who do not receive Residential/Commercial garbage, water or sewer services four (4) or more times per year in each of the aforementioned utility services areas, excluding officially recognized City holidays, physical or other impediments created by the customer to all Residential/Commercial garbage, water or sewer areas (e.g., locked doors, the presence of animals); and the three (3) days per annum per utility service area which may not be implemented because of mechanical malfunctions experienced by City-owned vehicles engaged in providing the utility services herein, shall be granted an automatic adjustment to their utility bills by the City's Finance Department as supported by utility records maintained by the City's Public Works Department, Utility Services Division, and Finance Department.
