

ORDINANCE #93-19

AN ORDINANCE OF THE CITY COUNCIL OF BETHEL, ALASKA, AMENDING TITLE 5, CHAPTER 5.20.020, ENTITLED VEHICLES FOR HIRE ORDINANCE, OF THE BETHEL MUNICIPAL CODE BY REVISING SECTION NO. 020, PARAGRAPH E, ENTITLED RATES.

BE IT ENACTED BY THE CITY COUNCIL OF BETHEL, ALASKA, AS FOLLOWS:

Section 1: Title 5, Chapter 5.20, of the Bethel Municipal Code is amended by revising Section No. 020, Paragraph E.

Section 2: This ordinance shall not be construed as abating any action now pending under, or by virtue of, prior existing laws or as discontinuing, abating, modifying, or altering any penalty accruing or about to accrue, or as affecting the liability of any person, or as waiving any right of the City under any section or provision existing at the time this ordinance is adopted, or as vacating or annulling any right obtained by any person, firm, or corporation, by lawful action of the City except as shall be expressly provided for in this title.

Section 3: If any part or provision of this ordinance or application thereof to any person or circumstances is adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part, provision, or application directly involved in all controversy in which this judgment shall have been rendered, and shall not affect or impair the validity of the remainder of this title or application thereof to other persons or circumstances. The City Council hereby declares that it would have enacted the remainder of this ordinance even without such part, provision, or application.

Section 4: Ordinance #93-19 amending Title 5, Chapter 5.20, Section 020 of the Bethel Municipal Code of Ordinances is hereby adopted as follows:

5.20.020 Rates.

E. Maximum rates for permitted transportation are as follows:

HALF HOUR FARE CHARTER	25.00
FARE AIRPORT TO AIRPORT	3.00
IN ROUTE STOPS: \$1.50 FOR 3 MINUTES; \$0.50 PER MINUTE THEREAFTER

MEMORANDUM

SUBJ: Error in Preparation of Ordinance #93-19

I received word from John Watts, Chairman of the Transportation Commission, that there is an error in the Vehicle for Hire ordinance that was introduced at the last Council meeting. Under Paragraph E, line #9, the words "Bus Fare, Senior Citizens 62/Older, with Senior I.D. \$1.00" should be entirely deleted, instead of only deleting the words "Bus Fare." This was a mistake I made when typing the ordinance.

Additionally, the deletion of line #5, "Fare to B.I.A. \$6.00" is incorrect. According to Mr. Watts, the Transportation Commission did not intend to delete this fare charge from the ordinance.

Note: Suggested additions are highlighted and suggested deletions are ~~everstruck~~.
