ORDINANCE #94-21

AN ORDINANCE OF THE CITY COUNCIL OF BETHEL, ALASKA, AMENDING TITLE 2, CHAPTER 2.04.010 ENTITLED SESSIONS AND CHAPTER 2.04.040 ENTITLED AGENDA OF THE BETHEL MUNICIPAL CODE.

NOW, THEREFORE, BE IT ENACTED BY THE BETHEL CITY COUNCIL AS FOLLOWS:

Section 1: Title 2 of the Bethel Municipal Code is amended by revising Chapter 2.04.010 and Chapter 2.04.040.

Section 2: If any part or provision of this ordinance or application thereof to any person or circumstances is adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part, provision, or application directly involved in all controversy in which this judgment shall have been rendered, and shall not affect or impair the validity of the remainder of this title or application thereof to other persons or circumstances. The City Council hereby declares that it would have enacted the remainder of this ordinance even without such part, provision, or application.

Section 3: Title 2 of the Bethel Municipal Code is hereby amended by amending Chapter 2.04.010 Sessions and Chapter 2.04.040 Agenda.

Section 4: Chapter 2.04.010 of the Bethel Municipal Code is hereby amended to read as follows:

2.040.010 Sessions. The sessions of the Council shall be held commencing at seven-thirty p.m. on the second and fourth Tuesdays of each month and continuing until eleven p.m. Business that is not completed by eleven p.m. will be carried forward to the next regularly scheduled Council meeting and addressed under Old Business. Special sessions may be called at any time that business requires upon call of the Mayor or one-third of Council members. Sessions may be advanced or

postponed by the Mayor if a quorum is made possible thereby.

Section 5: Chapter 2.04.040(B) of the Bethel Municipal Code is hereby amended to read as follows:

2.04.040 Agenda.(B) Public Notice of council meetings shall consist of:

1. Public posting of the council agenda no less than seven days before the council session in three conspicuous places in the city;
2. Certification by the city clerk that such posting, as described in subdivision 1 of this subsection, was actually done; and
3. Any other requirement which may be necessary to satisfy the laws of Alaska in relation to posting of public meetings.


Section 6: This ordinance shall become effective upon adoption.
