ORDINANCE #95-33

AN ORDINANCE OF THE BETHEL CITY COUNCIL AMENDING CHAPTER 2.04 OF THE BETHEL MUNICIPAL CODE, ENTITLED CITY COUNCIL, BY AMENDING SECTION 2.04.030, ENTITLED ORDER OF BUSINESS, AND BY DELETING SECTION 2.04.045, ENTITLED CONSENT AGENDA

WHEREAS, the City Council no longer wishes to use a Consent Agenda format in their Order of Business; and

WHEREAS, the City Council no longer wishes to impose a time limit on those citizens addressing Council under People to be Heard.

NOW, THEREFORE, BE IT ENACTED by the Bethel City Council as follows:

Section 1: If any part or provision of this ordinance or application thereof to any person or circumstances is adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part, provision, or application directly involved in all controversy in which this judgment shall have been rendered, and shall not affect or impair the validity of the remainder of this title or application thereof to other persons or circumstances. The City Council hereby declares that it would have enacted the remainder of this ordinance even without such part, provision, or application.

Section 2: This ordinance shall not be construed as abating any action now pending under, or by virtue of, prior existing laws or as discontinuing, abating, modifying, or altering any penalty accruing or about to accrue, or as affecting the liability of any person, or as waiving any right of the City under any section or provision existing at the time this ordinance is adopted, or as vacating or annulling any right obtained by any person, firm or corporation, by lawful action of the City except as shall be expressly provided for in this title.

Section 3: Section 2.04.030 of the Bethel Municipal Code is hereby amended to read as follows:

2.04.030 Order of Business.

Business shall be conducted in the following manner:

Call to Order

Roll Call

People to be Heard

a. Agenda Items Not Scheduled for Public Hearing

b. Items Other than Those Appearing on the Agenda

Approval of Minutes

Approval of Agenda

Mayor's Report



Council Member Comments
Executive Session
Adjournment

Council may by resolution establish a schedule of time lines for agenda items as it considers appropriate.

Section 4: Chapter 2.04 of the Bethel Municipal Code, entitled City Council, is hereby amended by deleting Section 2.04.045 entitled Consent Agenda.

Section 5: This ordinance shall take effect upon passage.
