ORDINANCE #96-1

AN ORDINANCE OF THE BETHEL CITY COUNCIL AMENDING TITLE 2 OF THE BETHEL MUNICIPAL CODE ENTITLED ADMINISTRATION, BY ADDING CHAPTER 2.18 ESTABLISHING A DEPARTMENT OF PORT AND HARBOR

NOW, THEREFORE, BE IT ENACTED by the Bethel City Council as follows:

<u>Section 1.</u> Title 2 of the Bethel Municipal Code is amended by adding Chapter 2.18, establishing a Department of Port and Harbor.

Section 2. This ordinance shall not be construed as abating any action now pending under, or by virtue of, prior existing laws or as discontinuing, abating, modifying, or altering any penalty accruing or about to accrue, or as affecting the liability of any person, or as waiving any right of the City under any section or provision existing at the time this ordinance is adopted, or as vacating or annulling any right obtained by any person, firm, or corporation, by lawful action of the City except as shall be expressly provided for in this title.

<u>Section 3:</u> If any part or provision of this ordinance or application thereof to any person or circumstances is adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part, provision, or application directly involved in all controversy in which this judgment shall have been rendered, and shall not affect or impair the validity of the remainder of this title or application thereof to other persons or circumstances. The City Council hereby declares that it would have enacted the remainder of this ordinance even without such part, provision, or application.

<u>Section 4:</u> Title 2 of the Bethel Municipal Code is hereby amended by adding a new chapter 2.18 to read as follows:

Chapter 2.18 Department of Port and Harbor

Section 2.18.010 Established. Section 2.18.020 Functions. Section 2.18.030 Director.

Section 2.18.010 Established. There is established the department of Port and Harbor.

Section 2.18.020 Functions.

The functions of the department of port and harbor shall include those set forth in Title 14 of the Bethel Municipal Code.

Section 2.18.030 Director.

The department of port and harbor shall be headed by the Port Director who Α. shall be appointed by the City Manager for an indefinite term and shall be removable by the City Manager.

The Port Director will have supervision of and responsibility for the operation Β. of all port and harbor facilities including but not limited to the Small Boat Harbor, seawall, cargo dock and petroleum dock in accordance with the operating rules and regulations enacted by the City Council and the administrative direction of the City Manager.

This ordinance shall take effect upon passage. Section 5.
