RESOLUTION 105

WHEREAS, the General Election of October 2, 1973, resulted in a less than 40% margin for any one candidate running for Seat 6, and

WHEREAS, the two candidates receiving the greater number of votes for Seat 6 were John Nicori Sr., and Al Romer Jr.,

THEREFORE BE IT RESOLVED that (1) the City of Bethel conduct a General Run-off Election, conducted in the manner specified by state and municipal law, between John Nicori Sr. and Al Romer Jr. for Seat 6, to be held October 16, 1973, between the hours of 8:00 AM and 8:00 PM.

(2) THE QUALIFICATIONS FOR ELECTORS AT SAID GENERAL RUN-OFF ELECTION ARE AS ESTABLISHED BY ALASKA STATUTES TITLE 15 AS FOLLOWS:

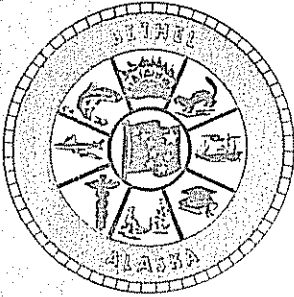
- (a) HAS PASSED HIS 18TH BIRTHDAY.
- (b) IS A CITIZEN OF THE UNITED STATES AND HAS BEEN A RESIDENT OF THE STATE AND OF THE ELECTION DISTRICT IN WHICH HE SEEKS TO VOTE FOR AT LEAST 30 DAYS JUST BEFORE THE ELECTION.
- (c) HE'S REGISTERED TO VOTE BEFORE THE ELECTION ACCORDING TO -
A S 15.07.010 - A S 15.07.200.

(3) THE POLLING PLACES WITHIN THE CITY ARE DESIGNATED AS FOLLOWS:

PRECINCT NO. 1: THE RECREATION BUILDING ACROSS FROM SWANSON'S STORE.

PRECINCT NO. 2: THE NEW BETHEL LIBRARY ON THE STATE HIGHWAY IN FRONT OF THE OLD BRAUND BUILDING.

- (4) PURSUANT TO THE REQUIREMENTS OF LAW, THE FOLLOWING ARE APPOINTED JUDGES AND CLERKS FOR THIS GENERAL RUN-OFF MUNICIPAL ELECTION TO SERVE IN THE MUNICIPAL VOTING PRECINCT AS SET FORTH IN CITY OF BETHEL ORDINANCE 46.
- (5) IN THE EVENT ANY OF THE ABOVE ELECTION OFFICERS SHALL FAIL TO TAKE THEIR OFFICE FOR ANY REASON, THE CLERK OF THE CITY OF BETHEL IS AUTHORIZED TO APPOINT OTHER QUALIFIED OFFICIALS TO TAKE THEIR PLACE IN THE MANNER PRESCRIBED BY LAW.

(6) AT LEAST FIVE DAYS BEFORE THE DATE OF THE GENERAL RUN-OFF ELECTION, THE CITY CLERK SHALL POST OR CAUSE TO BE POSTED A NOTICE OF SPECIAL ELECTION IN THREE PUBLIC PLACES WITHIN THE CITY OF BETHEL, ALASKA.

(7) ALL QUESTIONS OF VOTER RESIDENCE, QUALIFICATION AND ELECTION PROCEDURES SHALL BE GOVERNED BY THE PREVISIONS OF ALASKA STATUTES TITLE 15, AND ORDINANCE NO. 46 OF THE CITY OF BETHEL, PROVIDED, HOWEVER, THAT IN THE EVENT OF A CONFLICT BETWEEN THE ORDINANCES AND THE STATE STATUTE, THE PROVISIONS OF THE STATE STATUTE SHALL BE FOLLOWED.
