## RESOLUTION NO.113

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BETHEL, ALASKA, PROVIDING FOR THE SUBMISSION TO THE QUALIFIED VOTERS OF THE CITY AT A SPECIAL ELECTION TO BE HELD THEREIN ON MARCH 19,1974, OF A PROPOSITION ENABLING THE CITY OF BETHEL TO EXCERCISE THE POWER OF EMINENT DOMAIN AND DECLARATION OF TAKING FOR AQUISITION OF CERTAIN LAND AND IMPROVEMENTS FOR THE BROWN'S SLOUGH BETHEL SMALL BOAT BASIN CONSTRUCTION AND MAINTENANCE.

WHEREAS, Ordinance 63 needs ratification and/or approval of the duly qualified voters of the City of Bethel, and,

WHEREAS, The Council of the City of Bethel during a regular meeting held Monday, February 4,1974, set a Special election to decide this issue.

NOW THEREFORE, Notice is hereby given concerning a Special election of the City of Bethel to be held on March 19,1974. The proposition to be voted on at said Special election shall be as follows:

## PROPOSITION

SHALL THE CITY OF BETHEL ENACT AN ORDINANCE ENABLING THE CITY OF BETHEL TO EXCERCISE THE POWER OF EMINENT DOMAIN AND DECLARATION OF TAKING FOR ACQUISITION OF CERTAIN LAND AND IMPROVEMENTS FOR THE BROWN'S SLOUGH BETHEL SMALL BOAT BASIN CONSTRUCTION AND MAINTENANCE.

FOR THE EXCERCISE OF EMINENT DOMAIN, YES

There shall be two voting precincts for such Special election, which will be the same as those for the General regular Municipal election.

Precinct 1:

Commencing at a point where the Winter Trail crosses the South Boundary of Nunapitchuk Precinct, thence southeasterly across the Kuskokwim River to the divide between KisaralikRiver on the north and the Kwethluk River on the south; then meandering said divide to its intersection with an east-west line to a point of intersection with the boundary of Bethel #2 Precinct and Eek Precinct; thence north and northeast along the boundary of Bethel #2 Precinct to its point where the Winter Trail intersects the south boundry of Nunapitchuk Precinct, the point of beginning, except that area designated for Kwethluk Precinct.

Precinct 2:

Beginning at a point in the middle of the Kuskokwim River at its intersection with the 162 20' meridian of west longtitude opposite Helmick Point; thence due north to the intersection with the east-west line through the northermost point of Nunavakpak Lake; thence due east to 1/4 mile east of the Winter Trail; thence southwest along the winter trail to the City Limits of Bethel connecting with Willow Street extended; thence southwest along the centerline of Willow Street and the State Highway route to the airport; thence continuing in a southwest line to the northeast corner of Napaskiak Precinct; thence following the east boundry of Napaskiak Precinct and continuing to the north boundary of Eek Precinct; thence along an east-west line through the south end of Fowler Island, continuing along said line due west to midchannel of the Kuskokwim River; thence along mid-channel southwesterly to the point of beginning, except that specific area designated for Napakiak, Napaskiak, and Oscarville Precincts. The polling places for such Special election shall be the New Library for Precinct 2, and the Third Teen Building for Precinct 1.

The polls at such polling places shall be open from 8:00 A.M. to 8:00 P.M. on March 19,1974.

Any person is qualified to vote who:

Is a Citizen of the United States and who is qualified to vote in State elections and has been a resident of the City of Bethel for thirty (30) days immediately preceding the election and who is registered to vote in State elections and is not disqualified to vote under Article V of the Constitution of the State of Alaska.
