

(To accompany Application and Agreement)

WHEREAS, the City of Bethel, (herein called the "Political Subdivision"), through its City Council desires to make formal application to the Commissioner of Administration (herein called the "State Agency"), for inclusion of its eligible employees in an agreement between the State of Alaska and the Secretary of Health, Education, and Welfare for the coverage of such eligible employees under the insurance system established by Title 11 of the Federal Social Security Act, as amended, in conformity with Section 218 thereof, and implemented by Sections 11 - 7 - 1 through 11 - 7 - 8 of ASLA Cum. Supp. and applicable Federal and State regulations thereunder; and,

WHEREAS, the Political Subdivision desires to file such application and to enter into an agreement with the State Agency containing terms and conditions whereby the State Agency will take the necessary steps to extend to such eligible employees coverage under the said insurance system on behalf of the Political Subdivision; and,

WHEREAS, a form of application and agreement between the State Agency and the Political Subdivision containing the terms and conditions for the inclusion by the State Agency of the said eligible employees under the coverage of said insurance system on behalf of the Political Subdivision has been submitted to this body for consideration and action;

NOW THEREFORE BE IT RESOLVED, that the Political Subdivision execute the aforesaid application and agreement and submit the same to the State Agency for acceptance and that the State Agency be, and hereby is, requested to include all of said eligible employees of the Political Subdivision in an agreement between the State and the Secretary of Health, Education and Welfare for the coverage of said employees under the insurance system established by Title 11 of the Federal Social Security Act, as amended or as may hereafter be amended; and,

BE IT FURTHER RESOLVED, that for the purpose of said application and agreement, Lillie E. Schmidt, Clerk, Bethel, be, and he/she hereby is, designated as the Authorized Agent of the Political Subdivision and is hereby authorized and directed to execute a said application and agreement, as submitted, on behalf of the Political Subdivision and to forward same to the State Agency for acceptance and further action; and,

BE IT FURTHER RESOLVED, that the said Authorized Agent is further authorized and directed as the representative of the Political Subdivision to conduct all negotiations, conclude all arrangements and sign all agreements and instruments which may be necessary to carry out the letter and intent of the aforesaid application and agreement and in conformity with all applicable Federal and State laws, rules and regulations.
