CITY OF BETHEL RESOLUTION NO. 186

A RESOLUTION OF THE CITY OF BETHEL, ALASKA, PROVIDING FOR THE ESTABLISHMENT OF THE QUANTITY AND FREQUENCY OF WATER DELIVERY AND SEWAGE AND WASTE MATERIALS EVACUATION BY THE DEPARTMENT OF PUBLIC WORKS WITHIN THE CITY'S JURISDICTIONAL BOUNDARIES.

WHEREAS, the City of Bethel's Department of Public
Works is responsible for providing City-owned utility service
consisting of water delivery and sewage and waste materials
evacuation;

WHEREAS, utility service customers of the City have requested and shall receive regularly scheduled City-owned utility services in accordance with official applications for such services which have been approved by the Department of Public Works; and

WHEREAS, Title Eleven of the Bethel Code of Ordinances requires the City Council to approve the quantity and frequency of water delivery and sewage and waste materials evacuation regulations and orders promulgated by the Department of Public Works.

NOW THEREFORE, LET IT BE RESOLVED, that the City
Council of the City of Bethel hereby approves the following
City-owned utility quantity and frequency regulations and
orders of the Department of Public Works contained herein
and attached and referenced as a part of this resolution:

- A. UTILITY SERVICE DISTRICT I (Bethel Heights Subdivision)
 - 1. Quantity approximately 207 residential and commercial units averaging between 33 and 1,000 gallon water tank capacities, sewage tank capacities of 1 gallon to 1,000 gallons and an average of two trash containers per unit.
 - 2. Frequency an average of three days per week per utility customer relative to the delivery of water and the evacuation of sewage, and one day per week per utility customer relative to the evacuation of waste materials.
- B. UTILITY SERVICE DISTRICT II (1st Avenue and State Highway to Hanger Lake Road which encompasses 1st and 3rd Avenues and the Brown Slough Area.)
 - 1. Quantity approximately 300 residential and commercial units averaging between 33 and 2,000 gallon water tank capacities, sewage tank capacities of 1 gallon to 2,000 gallons and an average of two trash containers per unit.
 - Frequency an average of three days per week per utility customer relative to the delivery of water and the evacuation of sewage, and one day per week per utility customer relative to the evacuation of waste materials.
- C. UTILITY SERVICE DISTRICT III (3rd Avenue and State Highway to 7th Avenue, City Subdivision, and Airport Road beginning at 1st Avenue and continuing to the State Airport Facility.)
 - 1. Quantity approximately 300 residential and commercial units averaging between 33 and 2,000 gallon water tank capacities, sewage tank capacities of 1 gallon to 2,000 gallons and an average of two trash containers per unit.
 - 2. Frequency an average of three days per week per utility customer relative to the delivery of water and the evacuation of sewage, and one day per week per utility customer relative to the evacuation of waste materials.

- D. PIPED WATER AND SEWAGE SERVICES (District I, II, III)
 - 1. Bethel Regional High School (water and sewage services) approximately 1 million gallons per month.
 - 2. Bethel Native Corporation's Apartment Complex (sewage services) approximately 300,000 to 500,000 gallons per month.
 - 3. Bethel Heights Laundramat (water and sewage services) approximately 35,000 to 50,000 gallons per month.
 - 4. Alaska Native Health Services Hospital (sewage services) approximately 50,000 gallons per month.
- E. The attached Department of Public Works daily water delivery and sewage/waste material evacuation schedules shall be implemented and adhered to by the Department and are incorporated as a part of this resolution.
