

RESOLUTION NO. 191

CITY OF BETHEL, ALASKA

A RESOLUTION ACCEPTING LAND FROM BETHEL NATIVE CORPORATION FOR A PUBLIC CEMETARY.

WHEREAS, the City of Bethel desires to acquire suitable land for a public cemetery;


WHEREAS, Bethel Native Corporation will receive a tract of such land from the United States pursuant to the Alaska Native Claims Settlement Act:

WHEREAS, Bethel Native Corporation has offered to reconvey said land to the City, without charge, for use as a public cemetery, with the stipulation that comparable acreage outside of one-half ($\frac{1}{2}$) of the circumference of a five (5) mile radius having a center point known as "Watson's Corner", Corner No. 1 on U.S. Survey No. 3230A (Boundaries), and with the said one-half ($\frac{1}{2}$) circumference being northeast of a diameter running northwest and southeast, but within the City of Bethel's limits or immediately contiguous, will be accepted as a later date as part of the minimum 1280 acres Bethel Native Corporation must convey to the City under Section 14 (c) (3) of the Act.

NOW THEREFORE LET IT BE RESOLVED, that the City of Bethel hereby agrees to accept said land, the description of which appears on Exhibit "A" attached, for use as a public cemetery, the City further agrees that a tract of equal size located outside of one-half ($\frac{1}{2}$) of the circumference of a five (5) mile radius circle having a center point known as "Watson's Corner", Corner No. 1 on U.S. Survey No. 3230A (Boundaries), and with the said one-half ($\frac{1}{2}$) circumference being northeast of a diameter running northwest and southwest, but within the City of Bethel's limits or immediately contiguous shall be accepted as part of the minimum 1280 acres that Bethel Native Corporation must convey to the City under the Act. Survey and maintenance cost shall be borne by the City of Bethel. The conveyance of the cemetery site shall become null and void in the event that it is ascertained that there is an individual native land claim(s) against that property.

WHEREAS, the City of Bethel desires to dedicate suitable land for a public cemetery, and


WHEREAS, Bethel Native Corporation is willing to convey land to the City, without charge, comparable to the acreage which the City dedicates as a public cemetery, and

WHEREAS, the existing cemetery has very little usable space.

NOW THEREFORE BE IT RESOLVED, that the City of Bethel hereby agrees to dedicate said land, the description of which appears on Exhibit "A", Site #1(attached), as a public cemetery site. The City further agrees that a tract of equal size shall be accepted by the City of Bethel from the Bethel Native Corporation above and beyond the minimum 1280 acres the Bethel Native Corporation must convey to the City under the A.N.C.S.A., the description of which appears on Exhibit "A", Site #2(attached). This action hereby nullifying any previous dedication, of the sites above described, for any other specific purpose.

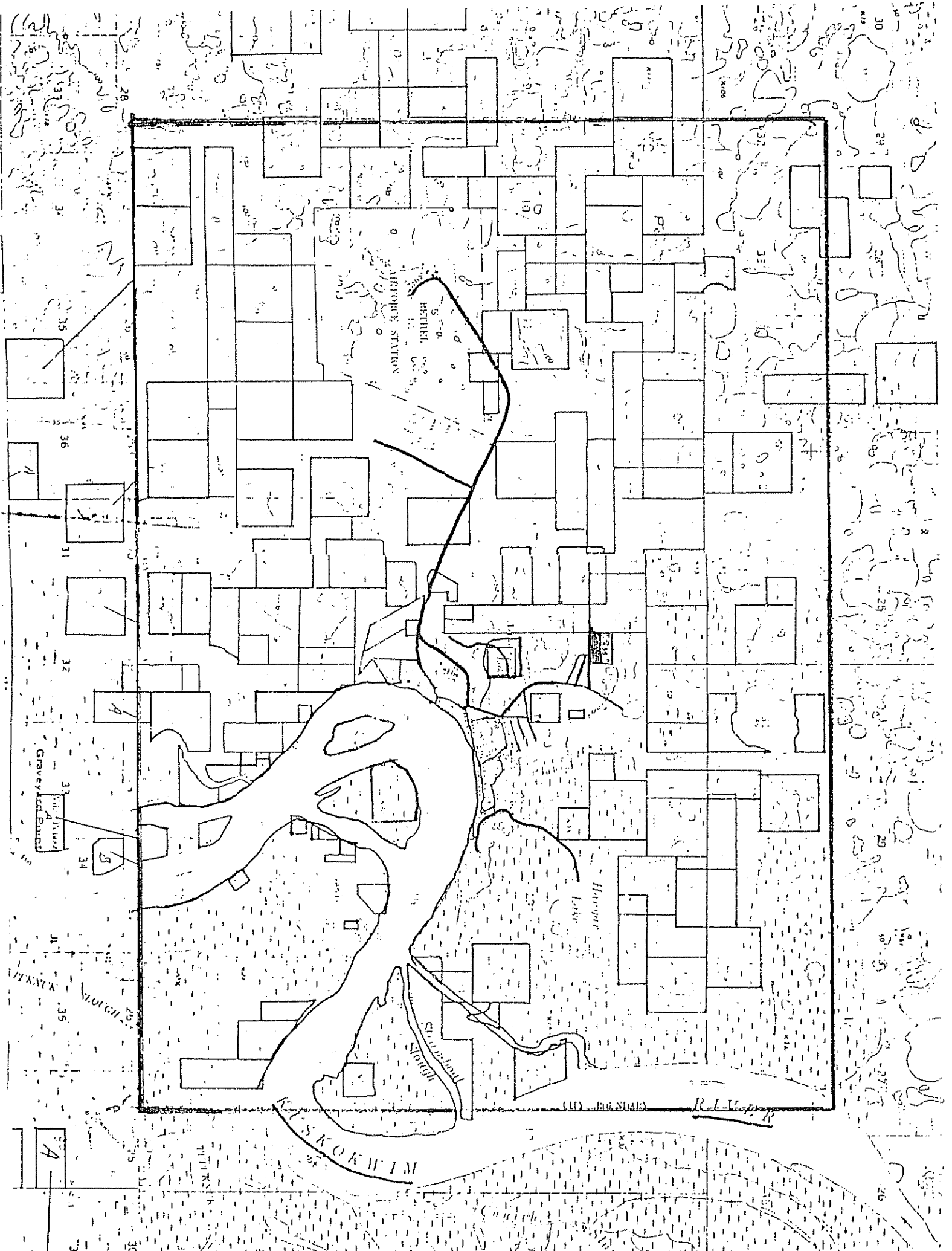

A RESOLUTION OF THE BETHEL NATIVE CORPORATION CONVEYING 15 ACRES TO THE CITY OF BETHEL FOR PUBLIC USE ABOVE AND BEYOND THE MINIMUM 1280 ACRES ENTITLED TO THE CITY OF BETHEL UNDER THE ANCSA LOCATED IN EXHIBIT A, SITE #2 AS LONG AS THE CITY OF BETHEL DEDICATES EQUAL ACREAGE AS A PUBLIC CEMETARY LOCATED IN EXHIBIT B, SITE #1.

WHEREAS, Bethel Native Corporation agrees that the City needs suitable land for a public cemetery, and

WHEREAS, the City of Bethel is willing to accept land, without charge, in comparable acreage if they dedicate a site for a public cemetery, and


WHEREAS, the existing cemetery has very little usable space,

NOW THEREFORE BE IT RESOLVED THAT the Bethel Native Corporation convey 15 acres to the City of Bethel for public use above and beyond the 1280 acres entitled the City of Bethel under the ANCSA and this 15 acres will be located in Exhibit A, Site #2 as long as the City of Bethel dedicated equal acreage as a public cemetery located in Exhibit A, Site #1.
