WHEREAS, Bethel Social Services, Inc. has secured a \$10,000, loan from the Department of Commerce and owns available land for this project;

WHEREAS, this facility will be a part of larger planned social service complex located on adjacent land;


WHEREAS, the Planning Commission and the Social, Economic, and Cultural Committee have both voted unanimous support; and

WHEREAS, this facility will be a part of a larger planned social service complex located on adjacent land;


