WHEREAS, Resolution No. 250 gives authority to Lyman Hoffman, City Manager, Irene Williams, City Clerk and Nancy Kraning, Assistant City Manager to enter into and officially represent the City Council of the City of Bethel in this action;

NOW THEREFORE LET IT BE RESOLVED, that the City Council of the City of Bethel authorizes the City Administration to enter into a loan agreement for \$50,000 for a period of

120 days at an interest rate of seven percent (7%) and recognizes Lyman Hoffman, Irene Williams, and Nancy Kraning as official signatures of all documents.


WHEREAS, the interim loan is requested for 60 days at eight and one half percent (8.5%) interest rate; and



WHEREAS, the interim loan is requested for 90 days at nine percent (9%) interest rate; and,


