PETITION

We, the undersigned Residents of Bethel Heights, hereby petition the Honorable Senator Mike Gravel, Senator for Alaska, to contact the responsible parties and obtain the following measures necessary for the health, welfare, and well-being of the Residents of Bethel Heights:

- 1. Temporary measures, such as gravel and grading; necessary to keep the roads open during breakup.
- 2. Temporary measures, such as gravel and grading, necessary to allow access to some of the housing by the residence and various service vehicles.

In support of the above request, the following conditions currently exist or will exist during breakup at Bethel Heights:

- l. During breakup, the condition of the roads will not allow sanitation vehicles, fuel service vehicles, and other necessary service vehicles access to the various housing units, thus resulting in making the housing units unfit for human habit ion and a threat to the health and welfare of the residents of Betnel Heichts.
- of the housing units other than by four wheel drive, heavy duck vehicles. This condition results in placing the residents and the various service vehicles and their drivers in danger to like limb and property by using the roads in their present condition.

- 3. Gravel is currently available in Sethel and its use on the roads at this time would not preclude its reclamation and reuse at a later time.
- 4. There is rumor of a legal dispute between the warious parties responsible for building permanent roads which way
 result in a long delay in completion of the permanent roads.

5. If this petition is not sufficent to obtain the requested temporary relief, we the undersigned will be forced to go to court to attempt to obtain relief from the above described intolerable conditions.
